Food / Pantry-Goods / Dry-Goods (spices)		<ul style="list-style-type: none"> <li>▪ Since May 6, 2009 the Food and Drug Administration (FDA) requires the submission to FDA of prior notice of food, including animal feed that is imported or offered for import into the United States.</li> <li>▪ Prior notice be submitted to FDA electronically via either the U.S. Customs and Border Protection (CBP or Customs) Automated Broker Interface (ABI) of the Automated Commercial System (ACS) or the FDA Prior Notice System Interface (FDA PNSI).</li> <li>▪ The information must be submitted and confirmed electronically as facially complete by FDA for review no less than 8 hours (for food arriving by water), 4 hours (for food arriving by air or land/rail), and 2 hours (for food arriving by land/road) before the food arrives at the port of arrival.</li> <li>▪ Food imported or offered for import without adequate prior notice is subject to refusal and, if refused, must be held.</li> <li>▪ Shippers must provide the authorities with advance notice of Human and Animal food shipments.</li> <li>▪ This can be done by accessing the following website: <a href="http://www.fda.gov/oc/bioterrorism/bioact.html">http://www.fda.gov/oc/bioterrorism/bioact.html</a></li> <li>▪ Once all the details of a shipment are reported the FDA will provide a registration number, which must be stated on all Bills of Lading as well as Air Way Bills.</li> </ul>	<ul style="list-style-type: none"> <li>▪ The link to information of prior notice and this rule changes is: <a href="http://www.cfsan.fda.gov/~pn/cpgpn7.html">http://www.cfsan.fda.gov/~pn/cpgpn7.html</a></li> <li>▪ Omitting to provide the authorities with the required information may result in delays, fines or even seizure of the shipment by the government.</li> <li>▪ Rules apply to beverages as well as food.</li> <li>▪ Recommendation: do not ship food with household goods.</li> <li>▪ Food can cause additional exams and delays, which ends with increased costs.</li> <li>▪ However if food is included, it can be processed through clearances, but may cause added expense or delays.</li> </ul>

<b>Firearms and dangerous goods</b>	<ul style="list-style-type: none"> <li>▪ Any firearms acquired overseas require approved U.S. Alcohol, Tobacco &amp; Firearms (ATF) permit before importing to the U.S.</li> </ul>	<ul style="list-style-type: none"> <li>▪ ATF Permit 6 can take months to obtain.</li> <li>▪ Do not ship any firearms without permit in hand.</li> <li>▪ Same person can import firearms purchased by importer in the U.S. back to the U.S. provided firearms were registered with U.S.</li> <li>▪ Customs before being exported from the United States. CBP Form 4455 or CBP Form 4457.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Do not ship firearms with Household Goods - ship separate via firearms dealer.</li> <li>▪ Explosives and other dangerous goods are either prohibited or require special permits.</li> <li>▪ If US Citizen exports firearms should file 4455 or 4457 w/ US Customs – use this for re-entry permission.</li> <li>▪ Not recommended for import.</li> </ul>

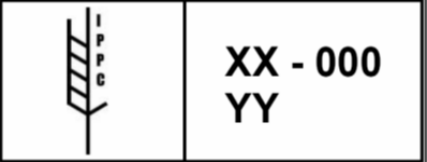

Bromide Treatment [the minimum temperature should not be less than 10°C and the minimum exposure time should not fall below 16 hours]).

- The wood packing material must be marked in a visible location on each article, on at least two opposite sides of the article with a legible and permanent mark in black ink. Labels and adhesives are not allowed.
- The mark should be as follows:



- Where XX is the country code, 000 the producer number, YY the treatment type, and AAA the inspection agency logo.

- Recommendation:
  - Do not use burlap coverings/bags. They will cause problems with USDA – especially air shipments.
