Customs Information

The customer is allowed to complete his /her first consignment with a second shipment within a timeframe period of six months from the date of his /her first arrival in Mauritius to be exempted of Duties & Taxes

All consignments consisting of personal and household effects entering to Mauritius maybe subject to customs inspection before delivery to customer residence except for diplomatic shipment. Customer will need to be physically present during the customs verifications.

Customs Clearance of Sea Freight shipment takes 4-5 working days and for Airfreight shipment it takes 2-3 days.

Alcohol

Alcohol is not prohibited; however, all alcohol is subject to duties and taxes that are applied by customs upon arrival in Mauritius. Quantity brought should be reasonable and for personal use only.

Client must do a separate list indicating the type, quantity, capacity and percentage of alcohols for customs clearance purposes. All alcohol must be declared at customs. Whether a new or already opened bottle, the customer has to pay the excise duties, duties & taxes.
