- 6. Reassembly of basic furniture that does not require specialist or third-party trade assembly (any item that requires two or more people for over 30 minutes to service is deemed a third-party service).
- 7. Return of empty containers (for FCL).
- 8. Building liability insurance, if required.
- 9. ISF filing.
