- *Normal FCL release fee to shipping line
- *One Delivery from LCL depot to residence within 50km radius / normal access
- *Unloading into residence up to 2nd floor
- *Un-crating up to 3 items
- *Unwrapping of furniture and setup
- *Debris removal on delivery day
- *Turn in of empty container to local depot only
- *Vehicle handover at depot
- *Basic assembly of items not requiring special tools / tradesmen

- *Random customs inspection related charges if ordered

*Storage if requested by client: charged at US\$3,80 per cubic meter per month (minimum US\$25/month),

PLUS handling fee once off US\$ 5,70 per cubic meter (minimum charge US\$50), PLUS re-delivery ex store US\$25 / cbm (Minimum re-delivery charge US\$85). Vat at 15% charged if billed to client directly.
