- *Collection from port, JHB inland terminal, LCL depot or airport of entry
- *Normal FCL release fee to shipping line
- *One Delivery from LCL depot to residence within 50km radius / normal access
- *Unloading into residence up to 2nd floor
- *Un-crating up to 3 items
- *Unwrapping of furniture and setup
- *Turn in of empty container to local depot only

RATES EXCLUDE

- *Random customs inspection related charges if ordered
- *Shuttle service if required / long carry charged at US\$8 per CBM (minimum US\$50)
- *Unpacking of cartons unless agreed. We have found that clients prefer to unpack at their leisure when they know what to place where.

*Storage if requested by client: charged at US\$3,80 per cubic meter per month (minimum US\$25/month),
