CUSTOMS REGULATIONS FOR IMPORTING HHGS TO PANAMA

For Panamanian Citizens Returning to Panama:

Copy of a valid Panamanian ID (Cédula) or Passport.

Proof of residence abroad for at least 12 consecutive months (utility bills, rental contracts, work permits).

Detailed, valued, and signed inventory list of all household goods.

Original Bill of Lading or Air Waybill.

Customs Declaration Form (Formulario de Declaración de Aduanas).

Tax Exemption Request (if applicable for returning citizens).

For Foreign Citizens Moving to Panama:

Copy of Passport and valid Residency Visa or Work Permit.

Detailed, valued, and signed inventory list of all household goods.

Original Bill of Lading or Air Waybill.

Power of Attorney notarized and authenticated, granting Best Move, Inc. authority to clear goods.

Proof of employment or residency in Panama (contract, visa resolution, attorney letter).

Customs Declaration Form.
