# **Customs Regulations for Imports to Andorra**

Dear Valued Client.

We would like to bring to your attention the essential customs regulations and document requirements when importing used household goods, personal effects, and vehicles into Andorra.

Ensuring compliance and provision of the required documents will facilitate a seamless customs clearance process. Failing to meet these requirements could result in additional taxes and duties.

#### **Household Goods and Personal Effects:**

## **Documents Required:**

- 1. Photocopy of the passport.
- 2. Detailed inventory in Spanish or English.
- 3. For Andorra citizens: A Change of Residence Certificate from the Consulate at the origin, indicating that the shipper has resided there for at least one full year. Note: There's a one-year window from the entry date into Andorra to import without charges.
- 4. For foreigners: Andorra Residence Permit.
- 5. Customs forms (will be supplied upon destination in Andorra).
- 6. Registration certificate from the Town Hall at the Andorran destination.

Additional Note for Foreigners: Customs may occasionally request both a Change of Residence Certificate from the Consulate at the origin and a Certificate of Registration from the Consulate at the destination. A Rental Contract might also be requested.

## **USED Vehicles (Cars & Motorcycles):**

**Regulations:** The vehicle should have been under the client's name for a minimum of 6 months and 1 day or 12 months and 1 day, based on specific status and the Customs entry in Spain, before shipping and prior to the cancellation of residence at the origin.

### **Documents Required:**

- 1. Refer to documents 1 and 6 mentioned above for household goods. If the vehicle is part of the same shipment, only one copy is required.
- 2. Original Property Title Certificate.
- 3. Original Technical Card (with details about the vehicle).
- 4. Copy of the purchase invoice.

#### Additional Notes on Vehicles:

- Starting from 1st January 2012, cars and motor vehicles are deemed IMO goods, unless the battery is disconnected, and the fuel tank is empty. Non-compliance will incur additional charges.
- Our service typically includes the provision of a temporary import permit. However, all
  other tasks such as final vehicle registration, Traffic Tax payment, change of number
  plates, and modifications to comply with EU Standards should be directly handled by the
  client or a specialized broker.

**Final Note**: Any deviation from the above-listed requirements might result in the imposition of taxes and/or duties.
