6. Reassembly of basic furniture that does not require specialist or third-party trade assembly (any item that requires two or more people for over 30 minutes to service is deemed a third-party service).
7. Return of empty containers (for FCL).
8. Building liability insurance, if required.
9. ISF filing.

1. Customs VACIS and intensive examination.
2. Port/CFS charges, if any.
3. SSL and NVOCC charges.
4. Unpacking of cartons, such as books, linens, fragiles. etc and additional USD 1.00 per CFT with min of USD 100
5. Special handling of bulky/heavy items such as pianos, pool tables, hot tubs, safes, stone sculptures, gym equipment, chandeliers, etc.
6. Reassembly of furniture that requires excessive labor, such as German Schrank, IKEA, or new & ready-to-assemble furniture.
7. Third-party services for assembling furniture (bunk beds/storage beds or wardrobes/shelving units), appliance servicing, electrician, plumbing, maid, and handyman services, as well as auto handling & repairing charges.
