Customs information:

Persons who qualify to bring in their own used personal effects without import duty and tax are :

- Diplomats on a full-privileged status. Although diplomatic shipments may entitle to free import duty/tax, however please be aware that the approval process may take 14 days or more after the shipment's arrival. Therefore, please note that port storage, container demurrage, etc are not free and to be bill additionally.

- Expatriates who obtain a working permit (one year permit)

- Returning resident who has been staying aboard for more than 12 months. (Come back to visit Thai not over one month

of each time and not too often). Client must have all stamps in and out of Thailand stamped in their passport booklet.

Also they must request traveling record from the Dept. of Customs and immigration here in Thailand. We can get this for them when they return but we must charge THB2500 for this service)

- The arrival of shipment must be within 6 months upon the owner's arrival.

- Used personal effects, book is not over 150 kgs.

- Reasonable quantity for person is usually each of major appliances, one liter of liquor and 200 cigarettes.

- Each person is allowed for two shipments, one by air and the other by sea.

- To avoid any customs problem of the food, please load into the end of container.

- To bring in a motor vehicle, the owner must obtain a permit prior to importation. Its specifications such as year, engine

power, brand, model, color, etc are required.

- Prohibited items are firearms, ammunition, short/wave radios, medical equipment, gold, silver, and pornographic.
