- *Debris removal on delivery day

*Storage if requested by client: charged at US\$3,80 per cubic meter per month (minimum US\$25/month), PLUS handling fee once off US\$ 5,70 per cubic meter (minimum charge US\$50), PLUS re-delivery ex store US\$25 / cbm (Minimum re-delivery charge US\$85).
