- *Port storage / demurrage / detention if incurred due to late documentation, customs inspection order etc
- *Commercial customs clearance for clients not qualifying for duty free entry of HH goods or vehicles,
will be charged at US\$150 additional
- *Any duties or taxes if applicable
- *Storage if requested by client: charged at US\$3,80 per cubic meter per month (minimum US\$25/month)
PLUS, handling fee once off US\$ 5,70 per cubic meter (minimum charge US\$50)
- *For FCL containers collected at Johannesburg inland terminal, rates exclude turn in fee to Durban if
