- *Turn in of empty container to local depot only

RATES EXCLUDE

- *Random customs inspection related charges if ordered
- *Unloading / unwrapping goods

- *Commercial customs clearance for clients not qualifying for duty free entry of HH goods or vehicles, will be charged at US\$150 additional
- *Any duties or taxes if applicable
