*Commercial customs clearance for clients not qualifying for duty free entry of HH goods or vehicles, will be charged at US\$150 additional

*Any duties or taxes if applicable

*Storage if requested by client: charged at US\$3,80 per cubic meter per month (minimum US\$25/month),

PLUS handling fee once off US\$ 5,70 per cubic meter (minimum charge US\$50), PLUS re-delivery ex store US\$25 / cbm (Minimum re-delivery charge US\$85). Vat at 15% charged if billed to client directly.
