**Please Note:**

- Few food items are permitted in air shipment.
- In Air Shipment, Unpacking and removal of debris are not included.
- The volumetric weight/actual weight, whichever is higher, would be chargeable by the airlines. Any items considered as oversized may incur an extra cost.
- Insurance on door-to-door services will be arranged by us at an additional cost of 3.5% of the value furnished by you.
- After the packing and once the shipment reaches at our transit warehouse, we shall share the final actual and volumetric weight chart.
- Attached customs regulations for import in personal goods in (UAE), along with a list of banned items.
- All the electronic equipment/items/furniture items should be dismantled & assembled by the party.
- The inventory sheet/packing list should be signed by the consignee with the destination address and the value of each item at the time of packing.

**Terms and Conditions:**

**Payment:**

- Payment 100% in advance (30% at the time of booking and 70% at the time of loading from the house). With written work order by Cheque/DD/Electronic Transfer (Bank Charges extra) or if the company it will mutually agree on credit terms.
- If the bill payment is in a foreign currency, the bank transfer charge would be borne by you. If the payment is made through a Credit Card, then 3% additional charges will be applicable on the total value of the invoice.
- All payments should be in favor of M/s. Agarwal Packers And Movers Ltd. only.
- M/s. Agarwal Packers and Movers Ltd. can hold the consignment due to non-receipt of any charges from your side.
- If the volume of the shipment increases/decreases, then the charges will be revised accordingly.
- If any casing/crating of any items in the shipment is required, then the final charges will be according to the final volume of the shipment. Normally, after casing/crating, volume increases by 20% to 30% of the actual volume.

**Custom:**

- We, Agarwal Packers and Movers Ltd., and Customs are hereby authorized to check each and every item of the shipment at any point in time for security purposes.
- As per the customs rule, your personal effects/household goods should be more than 6 months old, otherwise, it will attract customs at the origin/destination.
- Customs can check every item of the shipment at the time of inspection/Customs examination /Customs clearance, and may take under custody if any suspicious/illegal items are found, or may impose heavy penalties.
- Customer must be present at the time of Customs clearance at the destination.



## Transit Risk Coverage:

- We offer transit insurance coverage for your valuables at a rate 3.50% of the total declared value furnished by you.
- Upon the completion of the packing and preparation of the packing inventory sheet/packing list should be signed by the consignee with the destination address and the value of each item at the time of packing. The partial declaration of the value is not permitted as per the insurance company norms.
- The carrier and the agent shall be exempted from any loss or damage through accident, pilferage, fire, rain, any other road or river hazard, we therefore recommend that the goods should be insured.
- If party insured the consignment by self/at owner risk, then NO CLAIM/damages will be entertained by Agarwal Packers & Movers Ltd.
- The transit risk cover for your household shipment (if required) will be arranged by us through any authorized insurance company.
- Any damages/discrepancies that occur should be mentioned on the POD (proof of delivery) at the time of receiving of your shipment. If not informed at the time of receiving of the shipment, the claim will not be entertained by the insurance company.
- Insurance policy and claim procedure can be arranged for you on request. However, the amount received as FOV will be shown in the bill, which also contains the insurance premium.
- We are using shipping line/airline/freight forwarders for the movement of your shipment on your behalf and making all the payments to them for the same. In case of any claim, it will be settling according to the terms and conditions of the shipping line/ Bill of lading/ GC /Airway bill.

## Transit Time:

- The transit time will start only after getting the Customs clearance of your shipment from the Customs authorities.
- The shipment will move after you depart from the origin, as we have to collect the departure certificate from the airlines.
- Please check the origin/destination Customs rules and regulations before sending the shipment.

Agarwal Packers And Movers Ltd. will not be responsible for any delay of consignment delivery beyond its control, like natural calamities, political or general strikes, accidents, road block/traffic jams, congestion at the port, or government. Interventions and priorities and other such delays beyond our control.
