- 1. Port of Entry: Nhava Sheva**
- 2. Delivery: GANDHIDHAM city limits**
- 3. Services: Customs clearance, transportation, unloading, unpacking and removal of debris.**
- 4. All the below mentioned items will be cleared under separate BL.**
- 5. Estimated volume: As mentioned below:**

**a. Sea shipment: 100 Gross cuft of household goods shipped to POE: Nhava Sheva : USD 370**

- **Shipping line DO charge – USD 60-80/CBM for LCL / USD 350-450/20' and USD 550-750/40' approx. as per the actual receipt charges. We suggest to prepay this charge.**
- **Port charges / CFS: Around USD 40-60/CBM for LCL and USD 400-450/20' and USD 700-800/40' for sea shipment as per the actual receipt charges.**
- **We will bill back all the received charges with 10% service charge of Agarwal Packers and Movers Ltd., for paying the same on your behalf.**
- **Bank fee USD 50**
- **18% GST will be applicable on the above charges (GST can be exempted if you provide your office address proof and if you do the payment in foreign currency)**

### **IMPORTANT TO NOTE:**

**For clearance purposes we require a minimum 8 to 10 Working days after collecting Original passport so please inform your client accordingly.**

**Kindly get 14 days free detention period on the container from the shipping line at destination. Our quote is valid for 30 days from today and can be re-validated only upon request.**

### **Inclusions:**

- Normal customs clearance
- One delivery to residence based on easy access, not above the 1st floor
- Unloading of shipment at customer's residence
- Unwrapping and simple reassembly of furniture items
- Removal of debris during on the day of delivery only.

### **Exclusions:**

- Unusual or difficult access, upper floor delivery after 1<sup>st</sup> floor, Crane / Forklift Charges: for Heavy Cargo as per actual.
- Customs duty, taxes and other government charges
- Container / Airline rent, demurrage, detention
- Second Delivery point.
- Steam cleaning and fumigation etc. if required.

# CAR CLEARANCE

## Below rates and conditions for Motor Car/ Motor Bike Import clearance under TR:

Left Hand Steering Control cars cannot be imported. Below rates for Import clearance of Motor Car (ONLY FOR RIGHT HAND DRIVE CARS) & Motor bikes

Custom duty & Stamp duty: Roughly around 155.87% based on the depreciated value of the used car / bike under TR

Clearance time: Approx. 2 to 3 weeks as we would need to obtain Homologation certificate from Pune as well.

DO charges & THC: As per shipping line.

Warehouse charges & detention: As per Warehouse / CFS tariff

Stamp duties and administration charges at actual

Transportation charges at actual (If applicable)

Temporary registration & Insurance charges (if applicable) at actuals

### Conditions:

Separate B/L for Motor Car / Motor bike and separate B/L for HHG

Only right-hand steering and controls allowed in case of Motor Cars

Only speedometer indicating speed in Kilometers allowed for Motor cars.

Have photometry of headlamps to suit the "keep left" signal for Motor cars.

Old vehicles on TR to be registered at least 1 year prior to shipment in the name of Importer.

Make, Model and purchase documents required, and Date of manufacture should not be greater than 08 years.

Importation allowed only within 6 months of passenger's arrival under TR.

Vehicles should not be older than 08 years from date of manufacture as per pollution control norms 2016.

### Documents required:

- 1) Bill of Lading (3 sets) stamped and signed on the back side by passenger
- 2) Certificate of Insurance
- 3) Certificate of Origin
- 4) Product catalogue literature & Import baggage declaration
- 5) Custom duty to be paid online in favour of Commissioner of Customs. (will advise you later)
- 6) Cargo intimations advise that you may have received from Shipping Liner.
- 7) Contact person contact details and delivery address
- 8) Manufacturer's Invoice / Purchase Invoice
- 9) Freight Certificate
- 10) Original passport with visa stamp. (3-year-old passport prior to last arrival for TR verification of TR eligibility)
- 11) Original Registration of the vehicle to be in the name of the passenger in the country of registration with minimum usage of 1year
- 12) Resume and professional qualification of the passenger along with employment details
- 13) All registration papers, images, and catalogue (if possible)
- 14) List of additional /optional items with value and supporting invoice
- 15) GATT declaration
- 16) personal declaration form and Affidavit cm undertaking to be given to customs on 100 re stamp paper (we will provide the draft)
- 17) For foreigner's minimum 3-year employment visa, FRRO COPY, and work permit or residence permit is required long with Company's Undertaking on the company's letter head

- Storage charges
- Assembly for items requiring special skills or tools such as Plasma TVs, sound systems, IKEA /Flat board or any New/ high end Furniture.
- Handyman Services
- Specially handled items such as Pianos
- Parking permit, parking fees, society security charges.
