The vehicle <u>must</u> comply to be registered in Greece. <li data-bbox="501 1133 1206 1379">• Certificate of Repatriation If the client has obtained a <i>Certificate of Repatriation</i>, then the car can be cleared duty/tax free providing the car must be in the ownership of the client at least 6 months prior to the issuance of the Certificate of Repatriation.
