- **Unloading Delays**
Any charges resulting from unloading delays are excluded and will be promptly communicated upon notification by the carrier.
- **Red Sea Transit Surcharges**
Any additional charges imposed by shipping lines due to transit disruptions in the Red Sea are excluded and will be communicated as soon as they are confirmed.

Eligibility Conditions

- The applicant must have resided abroad for work purposes for at least 12 months prior to returning.
- The transfer must be permanent.
- The goods must be:
 - Household goods owned and used by the applicant

- **Intended for personal use**
- **Vehicles owned and used for at least 6 months prior to the transfer**

Vehicles (cars, motorcycles, bicycles, etc.)

Customs exemption applies only upon proof that the vehicle has been owned and used abroad for at least 6 months prior to the permanent transfer of residence to Italy.

General Documents

- **AIRE registration (minimum 12 months)**
- **Valid Italian passport**
- **Proof of permanent return to Italy**
- **Certificate of residence**
- **EORI number / VAT number**
- **Specific mandate (template can be provided upon request)**

For Vehicles

- **Vehicle registration certificate (libretto)**
- **Purchase invoice for valuation purposes or**
- **Self-certification affidavit (Dichiarazione sostitutiva di atto notorio)**

All of the above information is reflected in the attached form, which must be duly completed, provided that the importer already holds a certificate of residence.

If the certificate of residence has not yet been issued, the attached form will not be valid and a financial guarantee must be lodged instead.
