- *Concerning to FCL port fees, such as BL clearance, port storage and DTHC, they are estimated at between R\$5,000.00 and R\$9,000.00 (USD980 to USD1,765), with COSCO being the cheapest and Hague-Log the most expensive. The fees will be passed on in their entirety to the client or to your company, and must be paid after customs clearance and before delivery.*
