INCLUDES

- Direct supervision of all operational activities at the port of entry.
- Normal Customs Clearance.
- Delivery of shipment from the port of entry to the planned destination, provided the container can arrive directly at the destination.
- Unloading the vehicle with a tow truck.
- Unloading and unpacking household goods, except for items packed by the client (PBO).
- Assembly of basic furniture.
- Remove debris on the same day of delivery.
- Return the empty container to the container terminal.

EXCLUDES

- Handling in/out and storage in our warehouse facilities, if required
- Reimbursable Container Fee: are payments made to shipping lines to secure a container, refundable upon the container's timely return. We prefer Hapag-Lloyd and Maersk, which do not require this fee.
- Shuttle service, (\$350), if required.
- Freight Forwarder (NVOCC) Fee (\$350), if required.
- Extra time and personnel for unpacking boxes, if required.
- Delivery of the vehicle from our warehouse to the customer's residence, if required.
- Delivery in places with difficult access or with a long carry more than 25 meters from the truck to the residence.
- Delivery where items must be carried above a second floor without access to an elevator.
- Assembly of very complicated furniture or IKEA type furniture in its original packaging.
- Handyman and third-party services.
- Handling pianos, safes, or any object difficult to handle due to its weight, size, or shape.

ESTIMATED PORT CHARGES

What do they exclude?

Normal customs clearance for non-diplomatic shipments require approximately 14 calendar days. The estimated port charges specified in our offer cover this time frame. To avoid customs clearance delays and additional charges, the shipper must provide the requested documents and make the required payments in a timely manner.

COMMON MISTAKES TO AVOID AT ORIGIN:

- **Mislabeling of the packed items**
- **Packing list that does not comply with Ecuadorian regulations, which require a detailed inventory of the contents in each box.**
- Prohibited articles included in the shipment.
- New items listed as used in the packing list.
- Shipping more appliances than the number allowed, or any other breach of the restrictions and regulations established by Ecuadorian customs.
- Work related equipment and tools valued up to \$38,560 in 2026, are allowed as long as the shipper provides documentation which validates the activity. Certain restrictions apply.

The estimated port charges exclude the following:

- Taxes, fines, and additional customs inspections.
- When the documentation to be presented in Ecuadorian customs does not comply with regulations, the shipment can be pre-inspected to allow our customs broker to verify the content, correct the packing list and assure all items are labeled correctly. Although this inspection has an additional cost, it's a better alternative to attempting a customs clearance procedure when you know the paperwork and possibly other things will be sanctioned by customs authorities.
- Additional storage.
- Additional port terminal expenses.
- Demurrage charges. **Please see the information below.**
- Document translations. (We offer this service for an additional fee)

SHIPPING LINE CHARGES

FREE DAYS: To reduce demurrage charges in Ecuador, when possible, please ensure at origin, the required number of free days with the shipping line:

***Diplomatic shipments require 5 - 7 free days.**

***Non-diplomatic shipments require 14 - 15 free days.**

Please consider the following demurrage charges:

1 x 20' STD: Approx. USD 130 per day

1 x 40' STD: Approx. USD 150 per day

* We recommend you use: **Maersk, Hapag Lloyd, ONE, Evergreen.**

* Shipments arriving with an **NVOCC or Freight Forwarder** will generate additional charges.

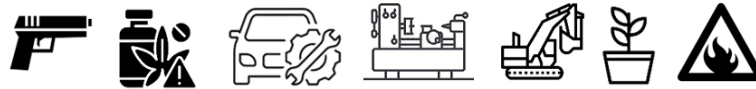
* Please be advised that **CMA-CGM and MSC**, apply reimbursable container fees in the thousands of dollars.

PROHIBITED ITEMS

The following items are prohibited: Weapons, drugs, narcotics, pornography, vehicle parts, industrial machinery, machinery parts, construction and remodeling material, decorative construction material, raw materials, plants, flammable cleaning items, farm items, etc. Please advise on any items not considered conventional household goods.
