Returning Resident /Student:

- →Who have been outside of Israel for over two years and have not visited more than four months per year.
- → Are allowed two duty-free shipments within nine months of return.
- →One of each normal household electronics or appliances are duty-free (3 TVs & 3 Computers)
- →Tax Free rights are for indoor, personal use only, however non-electric bicycles are also tax free

3 Tourist & Foreign Worker (B-1 Working Visa):

Household goods and personal effects are dutiable.

For B-1 visa ONLY - Alternatively a bank guarantee can be deposit at customs during import procedures which will be cancelled after goods have been exported out of the country.

Diplomat:

Household goods and personal effects are duty free upon presenting the appropriate customs forms signed by both the Embassy in Israel and Customs.






Customs Clearance & Delivery Procedures:

Upon your arrival in Israel, we strongly suggest you call us to synchronize the estimated arrival date of your shipment.

Prior to vessel arrival in Israel you will need to send us the required documents by email. Customs clearance will start as soon as your shipment arrives. This normally takes 2 - 3 days.



As part of our moving services, we will provide for the transportation of the shipment to your designated location where we will unload your shipment and unwrap only the large items. Basic assembling of furniture (simple used beds & used tables) is also included and will be done by the delivery team on the same day.

Local charges in Israel:

In accordance with the package of services you purchased, we would like to remind you that local fees in Israel are normally excluded and must be paid in Israel. (Please check with your salesman.) We will pay those fees and invoice you as charged (we can supply invoices as back-up on request).

Israeli Customs may call for a customs inspection.

In such case you will be notified, and related charges will be invoiced to you once the inspection is complete as this service is excluded.

Customs does not charge for the inspection, however you must have a customs' clearer (us) arrange the transport of the cargo to the inspection point and back, as well as supply workers to be present in the event that the goods need to be opened and physically inspected.


