PERUVIAN CUSTOMS REGULATIONS FOR IMPORTS OF HHGs AND PERSONAL EFFECTS

***Required Documentation for HHGs and Personal Effects:**

- Detailed Packing List (avoiding PBO items)
- 03 Original OBLs (**Freight Rated**)
- Copy of AWB (**Freight Rated**)

Sea Shipments:

- Client's Original Passport
- Notarized Power of Attorney Letter (as per sample we will provide)

Air Shipments:

- Notarized copy of client's passport (data + last entry stamp to Peru)
- Notarized Power of Attorney Letter (as per a sample we will provide)

In case client is travelling with family and in case customs request them the following documents will be needed:

- Copy of passport of family group (husband/wife/children. data + last entry stamp into Peru)
- Copy of marriage certificate
- Birth certificate of children
- Notarized copy of work contract issued by the local company and presented before our Ministry of Labor

(Client must be in Peru during the import process)

POE: CALLAO - Customs clearance: 8 to 10 working days, *from the time shipment is registered to the SUNAT/ADUANET system (48 hours after the arrival approx.).*

AOE: LIMA - Customs clearance 4 to 5 working days.

Shipment **must arrive** after the client's arrival into Peru, our **green light** is given when we have knowledge of client's date of arrival to Peru.

Useful information:

- OBL/AWB must state "Used Household Goods and Personal Effects"
- HHGs and unaccompanied baggage shipments can arrive up to 180 days after owner's arrival to Peru
- When shipping HHGs and vehicles in the same container, they must be clearly stated in OBLS
- Please take in consideration that Peruvian Customs authorities applies fines when shipment weights exceed or is less than 5% of the weight declared in the original documents. Therefore, please state the exact weight in the OBL/AWB.

***Restricted Items:**

A special and mandatory license will be required prior the arrival of the shipment for these items: firearms, ammunition and telecommunication Equipment like telephones, fax machines, etc.

Also, any artifact containing refrigerating gas: refrigerators, wine coolers, A.C. any telecommunication devices will require a specific license.

*(Without the specific license these items may be confiscated by Peruvian Customs Authorities until proper documentation is presented. This may end up generation extra charges so **please advise before packing** in order to request any license with time. Also*

applies for diplomats)

***Wooden Packing Materials:**

According to the ISPM 15 (International Norm of Phytosanitary Measures), every wooden packing material to be imported to Peru, must have the seal that shows that the product has been treated according to its specifications. Please take in consideration in your export shipments because those shipments which don't follow these specific regulations will not be allowed into Peru.

***Diplomats:**

Total franchise will be granted to:

- Diplomats and embassy offices
- Members of foreign armed forces working on official missions -Foreign representatives of International Organizations

Documents required:

- 03 Original OBLs or AWB (freight rated)
- Detailed packing list (avoiding PBO items)
- Client's original passport
- Free entry permit issued by our Ministry of Foreign Affairs

***Foreigners:**

All shipments are inspected by Peruvian Customs Authorities (except foreign diplomats). 14% duties will be applied on household goods shipments based on the value given by Peruvian Customs authorities after shipment's inspection. If clients wish to be present during the inspection, a prior coordination with our import department will be necessary.

***Returning Peruvian Citizens:**

Those who have lived abroad for 3 years or more, can apply for the New Incentive Migratory Law that gives the benefit of eliminate the Import/duties charges over their Household Goods or, if you have exported your Household Goods and those items are returning, (with export documents) will obtain tax exoneration as well. Please advise in order to inform the client.

If that is not the case 14% of duties will be applied if the citizen has been living abroad for a minimum of 13 consecutive months. Otherwise, a 33% of duties will be applied over the value given by Peruvian Customs authorities after shipment's inspection.

***Motor Vehicles:**

In Peru it is allowed to import new and used motor vehicles only under the following conditions:

- Used cars will pay 75% and new ones 35% of duties based on CIF value
- In the case of a used vehicle it **cannot exceed a maximum of 2 years since manufacturing date** to be imported into Peru.
- Vehicles **cannot exceed 32,000 kms (19,000 miles) of use**
- Only cars owned by diplomats will be free of duties
- Returning Peruvian diplomats after having completed their missions abroad, have the right to import only one (01) car free of duties

Documents required:

- Gas emissions certificate (to be obtained in Peru)
- Vehicle's technique specifications (to be obtained in Peru)
- 03 OBLs or AWB
- Fully detailed commercial invoice
- Owner's original passport
- Vehicles belonging to foreign or Peruvian diplomats, it will be additionally required a duty-free resolution issued by our Ministry of Foreign Affairs

***Pets:**

We recommend sending pets as unaccompanied baggage, otherwise they will pay custom taxes.

Under this condition, they will require:

- Zoo sanitary certificate
- Vaccination certificate

There is no quarantine period required for cats and/or dogs' importation to Peru.

****Important:**

Please be noted that all of the shipments that arrive to Peru, will generate local charges at port; such as THC and Port charges, Customs Inspection fees, Storage at Port, Demurrage of Container fees (if apply) and Import duties/taxes.

*This complete amount will be provided by Peruvian Customs by the end of the clearance and we will need to receive the funds **in advance** in order to proceed with payments at Port and release the cargo for delivery.*
