***Custom Clearance Process:**

- **POE: CALLAO** - Customs clearance: 08 to 10 business days approx. (*from the time shipment is registered to the SUNAT/ADUANET system (48 hours after the arrival approx.)*).

- **AOE: LIMA** - Customs clearance 04 to 05 business days approx.

Dates are estimates and subject to change

***Suggestions:**

- Avoid using shipping lines: *Mediterranean, CMA CGM*
- **For FCLs:** Request the shipping line from origin for an extension of *15-20 free days* for demurrage at destination

***Peruvian Citizens** that have lived abroad for 03 years or more, can apply for the New Incentive Migratory Law that gives the benefit of exonerate them from the Import/duties charges over their Household Goods and Personal effects.

Also, if client have previously exported their Household Goods and those same items are returning, (with export documents) will obtain tax exoneration as well.

Please advise in order to inform the client.

PAYMENT INFORMATION:

****Please be noted that all shipments that arrive to Peru, will generate local charges at port/airport, such as THC and Port charges, Customs Inspections fees, Storage at Port, Demurrage of Container fees (if apply) and import duties/taxes.**

The complete amount of the local charges will be provided by Peruvian Customs officials by the end of the clearance. We will need to receive the funds in advance to proceed with payments at port/airport and release the cargo for delivery.

Please inform if the client will be responsible for these charges or will the booking agent be responsible for them.

We do provide credit for destination services for FIDI members (30/45 days) but local charges must be paid in advance.

Under no circumstances, the amounts corresponding to the above-mentioned payments will be assumed by our Company.

LCL may result on expensive storage and deconsolidation charges.

Customs Inspection	USD 200.00
Storage at Port	USD 95.00 / 125.00 per day (08-12 free days)
Demurrage of container <i>(If apply)</i>	USD 185 / USD 245 per day / 05-06 free days (based on previous agreement with the shipping line)
Import Duties	Determined by customs agents during the inspection
