## CUSTOMS REGULATIONS FOR DUTY AND TAX FREE

## **DOCUMENTS REQUIRED:**

### TAIWANESE:

- 1. Scanned copy of passport with signature pages
- 2. Scanned copy of Taiwan ID front and back
- 3. E-Ticket to Taiwan within the last six months prior to the arrival of the shipment
- 4. Scanned copy of entry stamp of the aforemention flight to Taiwan
- Customs Declaration Form (Must obtain from customs upon arrival at the airport in Taiwan)
- 6. Inventory List

## NON-TAIWANESE:

- 1. Scanned copy of passport with signature pages
- 2. Scanned copy of resident permit or work permit (NOT work visa on the passport)
- 3. E-Ticket to Taiwan within the last six months prior to the arrival of the shipment
- 4. Scanned copy of entry stamp of the aforemention flight to Taiwan
- Customs Declaration Form (Must obtain from customs upon arrival at the airport in Taiwan)
- 6. Inventory List

## DIPLOMAT:

- 1. Scanned copy of passport with signature pages
- 2. Scanned copy of ARC or work permit (NOT work visa on the passport)
- 3. E-Ticket to Taiwan within the last six months prior to the arrival of the shipment
- 4. Scanned copy of entry stamp of the aforemention flight to Taiwan
- 5. Duty-Free Exemption Letter issued by Taiwanese government
- 6. Alcohol Duty-Free Exemptioin Letter issued by Taiwanese government (if necessary)
- 7. Inventory List

## **VEHICLES:**

- 1. Copy of passport
- 2. Taiwan ID for Taiwanese
- 3. ARC and work permit for Non-Taiwanese
- 4. Certificate of Title
- 5. Bill of Lading
- 6. Copy of vehicle invoice

#### ALCOHOL:

Each importer is allowed to bring one liter or less without any limitation on the number of bottles for duty and tax free. Importer has to declare to Taiwan customs upon arrival at the TPE/KAO airport if imported alcohol is more than 1 liter but less than 5 liters, subject to duty and tax. Shipping more than 5 liters will be considered as smuggling and is subject to penalty.

## FOOD:

Food is not allowed to ship with the personal effects' shipment to Taiwan.

## TOBACCO:

Each importer is allowed to ship 200 cigarettes, or 25 cigars, or 1 pound of tobacco for duty and tax free. Importer is required to declare to Taiwan customs upon arrival at the TPE/KAO airport in Taiwan if shipping more than 200 but less than 1000 cigarettes, or more than 25 but less than 125 cigars, or more than 1 but less than 5 pounds of tobacco, subject to duty and tax. Any additional quantity is prohibited from importing. Failure to conform is subject to imprisonment and penalty.

## **DRUGS & MEDICINES:**

Prescription drugs and medicines are restricted items. Please kindly consult us prior to packing. Illicit drugs are prohibited from importing to Taiwan. Failure to conform is subject to imprisonment and penalty.

#### **ANTIQUE & COUNTERFEIT:**

Antique items are restricted items. Please kindly consult us prior to packing. Counterfeit items prohibited from importing to Taiwan. Failure to conform is subject to imprisonment and penalty.

#### VALUABLE:

Beacon does not accept goods such as paper-currency, coins, art collections, and other valuables to be packed in the shipment as these items exceed the value allowance from importing to Taiwan. Failure to conform will be charged as smuggling and is subject to penalty.

All in all, client is responsible to personally check and confirm if items are allowed to be imported.

#### **INFORMATION:**

All payments are due prior to the delivery. We will send invoice ahead of time for you to process international transaction. And please note that all international wire transfers are subject to bank transaction fee USD45, which will be included in our invoice.

For LCL shipment, our quote only includes first 5 days of storage at the port. If any reason causing the delay of delivery other than clearace process such as but not limited to: delay of payment, absence of the client, and etc, client will need to take full responsibility of the consequences, as well as any additional storage charges and penalty.

For FCL shipment, please note that customs would randomly select shipment for inspection. If occurred, inspection fee would be incurred. Please inform us who should we bill the charges to in advance as we need to collect all payment prior to the delivery.
