- ✓ **Shipper's Passport** – can be a foreign passport - (if shipper holds a US Passport, we will need an EIN or Tax ID number, we can execute this for the shipper)

- ✓ Full export packing and wrapping of the household goods and personal effects into high grade packing materials
- ✓ Physical loading of personal effects into Container/LV/Crate
- ✓ Complete export documentation of household of goods through US Customs
