IMPORTANT:

Import of used household goods and personal effects (except diplomatic goods) to Russia is subject to payment of import customs duties and taxes - **4 EURO per 1 kg gross**. Import customs duty & taxes should be paid min. 3 - 5 days prior to shipment's arrival to customs terminal. Some returning citizens of the Eurasian customs union may be eligible for duty free import, if they meet the legal requirements.

Registration of Cultural Items:

Certain items are classified as "**items of cultural value or cultural designation**" by Russian customs and are subjected to special regulations of transfer through customs border (paintings, musical instruments, weapons, medals, items over 50 years old, etc.). They need to be registered upon arrival to ensure smooth export. We need 2 photos and the list of cultural objects and their description (author, size, date of creation and manner of performance, for example – oil / aquarelle for pictures). Shipments containing items of cultural value which require registration are more likely to be reviewed to verify the items being imported. The checks may result in delay of customs clearance and additional charges.

Payment conditions:

The invoice will be based on the actual weight / volume. IMS requires prepayment **unless otherwise specified**. Charges paid by IMS (e.g. THC, customs duties, storage, etc.) will be billed back at actual + pre-financing fee.
