



IMPORT TERMS & CONDITIONS

SERVICES INCLUDED

- > Customs Clearance for used household goods and personal effects
- > Container Drayage
- > Unloading FCL- directs to residence
- > Same day full unwrapping and setting up of furniture items
- > Removal of debris on the day of the delivery only
- > Delivery to residence on good access up to 1st floor
- > Return of empty container to terminal
- > Documentation and handling
- > Free port storage for 5 working days from vessel arrival date
- > Unpacking of cartons to bench top/ flat surface only
- > Basic reassembly of dining tables & beds only

SERVICES EXCLUDED

- > Import duties and taxes
- > unpacking PBO boxes
- > Port Storage
- > Shuttle Service
- > Chassis Fees
- > Customs inspection, X-Ray and DTHC
- > Delivery above 1st floor, bad access (long walk, shuttle, etc.).
Delivery of heavy furniture (pianos, pool tables, safes, etc.) This also includes Stair Carry/ Long Carry/ Elevator
- > Deliveries on Sundays and public holidays
- > Demurrage, bond charges, container detention, warehouse storage, pet transportation
- > Specialist service such as carpenter, maid service, electrician, plumbers, etc.
- > Reassembly of pre fabricated or knockdown furniture such as IKEA type furniture, bookcases, wardrobes, outdoor items, gym equipment, new furniture etc.
- > Village entrance/ parking fees (if applicable)
- > Bank charges of US\$35 per remittance

LCL SHIPMENTS

- > Destination Tariff Terms & Conditions apply
- > Shipments must be crated or palletized
- > Import Customs Clearance Fee: \$125.00

FCL SHIPMENTS

- > Destination Tariff Terms & Conditions apply
- > 20' Based on 6500 lbs Gross
- > 40' Based on 13000 lbs Gross
- > 800 CFT - Minimum Volume
- > 1600 CFT - Minimum Volume

TERMINAL HANDLING CHARGES

- > **LCL/NVOCC/AGENCY FEE/ OFF-DOCK** Warehousing Charges: US \$100.00/cbm to US\$350.00/cbm, depending on the consolidator used.
- > **THC** (FCL Shipments): US\$200.00 to US\$300.00 per 20' & US\$300.00 to US\$400 per 40'
- > **CIF** – Container Imbalance Fee: US\$200.00 to US\$250.00 per 20' & US \$500.00 per 40' (if applicable)
- > **CRS** – Container Recovery Surcharge: US\$200.00 to US\$250.00 per 20' & US\$500.00 per 40' (if applicable)

***Please load directly with a shipping line in order to avoid **consolidator's turnover fees** (US\$180/HBL)

Please note that above air, seaport charges are estimates and will be billed as per receipt.

- > LCL/ NVOCC / AGENCY FEE/ OFF_DOCK Warehousing Charges: at cost +\$95.00 Admin Fee, if not prepaid
- > THC (FCL Shipments): at cost +\$95.00 Admin Fee, if not prepaid
- > CIF - Container Imbalance Fee: at cost +\$95.00 Admin Fee, if not prepaid
- > CRS - Container Recovery Surcharge: at cost +\$95.00 Admin Fee, if not prepaid
- > Shuttle Service (US\$200/20' & US\$350/40')
- > NOTICE: 15-day period to lodge goods declaration is hereby shortened to seven (7) days
