Kindly ensure the charges pre-paid also includes consolidators port handling charges stripping/ mechanic/ equipment/ Forklift, etc., charges at the destination port and if not prepaid will be billed back as actuals. The consolidators have a tendency not to mention such charges are also involved at destination port warehouse bill in addition to the port warehousestorage bill during the clearance process.

(Please note: FCL clearance & delivery charges are cheaper than the LCL Clearance & delivery charges for shipments volumes above 8CBM).
