On the 6<sup>th</sup> March 2019, Heather Humphreys TD, Minister for Business, Enterprise and Innovation, and Charlie Flanagan TD, Minister for Justice and Equality, announced changes to immigration arrangements for spouses and partners of Critical Skills Employment Permit (CSEP) holders and Researchers under a Hosting Agreement as provided for under the EU Third Country Researchers Directive (Council Directive 2005/71/EC).

These changes allow for spouses and partners of CSEP holders and Researchers under Hosting Agreements to access the labour market without the need for an employment permit. These changes take immediate effect.

The Irish Naturalisation and Immigration Service (INIS) of the Department of Justice and Equality will grant eligible spouses and partners of CSEP holders and Researchers under Hosting Agreements permission to reside in this State on Stamp 1G Conditions without the need to obtain a Dependant/Partner/Spouse Employment Permit from the Department of Business, Enterprise and Innovation. This means that eligible spouses and partners of CSEP holders and Researchers under Hosting Agreements may access the labour market when they receive this Stamp 1G, and no longer need to obtain a Dependant/Partner/Spouse Employment Permit.

An eligible Dependant of a CSEP Holder or Researcher under a Hosting Agreement still requires an Employment Permit to work in the State.
