### About your application for Transfer of Residence (ToR) relief

Thank you for your application for ToR relief.

We have approved your application and given you the following Unique Reference Number (URN), 06086624.

Your URN only covers imports which arrive in the UK from 01/01/2025 to 01/01/2026

### What you need to do now

You need to now complete an import declaration if the goods that you're bringing to the United Kingdom are entering the country separately to your arrival. If you are using a shipper or agent to assist with your move, you need to give your URN to them so they can make an import declaration on your behalf.

This authorisation also allows you, or persons acting on your behalf, the ability to use the appropriate Special Combined-nomenclature Code outlined in Chapter 99 of the Tariff of the United Kingdom reference document when completing a written or electronic import declaration. This will allow you to use this single code to declare all your household effects, with the exclusion of excise goods or those subject to any prohibition or restriction.

Restricted goods will need to be identified separately on the import declaration, in case of Border Force inspection.

You are responsible for telling your agent or shipper if you are importing any goods which are not covered by this relief.

### If you no longer meet the conditions of the relief

You must notify the Transfer of Residence Team immediately at [nch.tor@hmrc.gov.uk](mailto:nch.tor@hmrc.gov.uk) and provide full details of why you may no longer meet the conditions of the relief.

You might, for example, need to sell your vehicle in the 12 months after moving to the UK, which may breach the conditions of the relief. You can find details about the conditions that apply on gov.uk <https://www.gov.uk/guidance/transfer-of-residence-to-great-britain>.

## Notification of vehicle arrival

If you are importing a vehicle into the UK, you must make a Notification of Vehicle Arrival (NOVA) application once the vehicle has arrived in the UK. To do this, please email the CARs team at [ecsm.nhcars@hmrc.gov.uk](mailto:ecsm.nhcars@hmrc.gov.uk) with "NOVA Application" in the subject heading and provide:

- Your full name
- Your address
- Your telephone number
- Your email address
- Your URN
- A copy of your official vehicle details - certificate of title
- Date of vehicle arrival in the UK
- A copy of the C88/MRN paperwork if a shipping agent has been used to bring the vehicle to the UK

## Corresponding with HMRC by email

Use the following information to decide whether you want to deal with us by email. We take the security of personal information very seriously.
