- 3 Customs inspection and scanning attendance (100% scanning applies).
- 4 Port storage and demurrage — please state the free-time allowance.
- 5 Haulage from port of discharge to Al Reef, Abu Dhabi.
- 6 Delivery to residence, unloading and placement in rooms.
- 7 Unpacking and removal of packing debris (single trip).
- 8 Container return to depot.

Additional items — please quote separately if applicable:

- 9 Shuttle service, should the 20' container not access the property directly.
- 10 Long-carry or stair-carry, if applicable.
- 11 Assembly of beds and furniture.

QUESTIONS

- 1 What documentation do you require from the consignee for customs clearance, and by when?
- 2 Is a pre-arrival deposit required against port and government charges?
- 3 Are import duties or VAT expected on any category within a personal effects shipment? The inventory includes a small number of **unused kitchenware and dinnerware items in original packaging**, and we would like to know how these are typically assessed.
- 4 The inventory includes **religious decorative articles** (statuary, a crucifix and framed artwork with religious motifs) for personal household use. Please confirm there is no restriction and advise how you prefer these declared on the packing list.
- 5 The shipment includes an **electric bicycle**. The lithium battery will be removed at origin and will not travel — only the bicycle frame ships. Please confirm this presents no issue at destination.
- 6 What is your standard transit time from vessel arrival to final delivery?
- 7 Please confirm your rate validity period.
